June 26, 2012

Proceedings: Meeting called to order at 6 pm at Malibu's Restaurant by Al Forbes, President

**RHS Lacrosse Coaches** (Ann Ehler, Doug Kuhblank)

**July Lacrosse Camp:**

1. Field Equipment needed for 2<sup>nd</sup> camp: None
2. Camp dates confirmed: boys 7/9-12, 5:30-8 pm; girls 7/16-19, 5:30-7:30 pm; no cost associated with camp.
3. Other clinics and camps: Al will post information on web for summer and fall. Many organizations are offering clinics/camps/competitive teams (Viera, Cocoa Beach, Holy Trinity, Brevard Lacrosse Club)

**Equipment/Grant Status:**

1. Uniforms: Doug and Ann will meet to select uniforms; recommended that uniforms be ordered sometime in August

**RHS Lacrosse Boosters**

**President:** Al Forbes

1. Friday Night Locker Room update: Al was featured on Friday, 6/22. He promoted lacrosse in Brevard County (school teams as well as travel team).
2. June tournaments with Jays: Al gave recap of season tournaments. Although travel team had many losses during the season, team finally jelled during the last set of games. He noted that Brevard County's interest in lacrosse is definitely growing.

**Vice President:** Amy Moon (Fundraising)

1. Fundraising selection review: List of ideas include creating a link on website for parents/friends to pay for a "shout out/friendly message" to a player; restaurant cards; Daytona concession; college bowls; bucket drop; barbecue; candy sales; golf tournament; Rock Night Out at Manatee Stadium (August 11)
2. Fundraising on website: We will work on posting fundraising activities on website so there is immediate opportunity for purchasing (ie. Donut sales). Al will work with Jim and Amy to post fundraising opportunities and sign-up.
3. Player fundraising: Treasurer will keep track of each player's participation in fundraising.
4. Captains: Each fundraiser will have a specific captain to monitor event; sign up will be on web.
5. RHS Lacrosse magnets: Members liked the idea of a lacrosse magnet – inexpensive/good promotional piece. Al recommended Al's Trophy Shop as vendor. Magnets should remain simple with basic logo (no eye changes for boys/girls team)
6. Team picture: Amy offered her photography services at cost and will give a percentage back to the team.
7. Club sponsors: My Locker; Prep Sportswear; Al is working with Warrior (equipment) and Underarmour.
8. RHS Registration: Suggestion was made that fundraising/sport promotion begin when students return for registration in August. Ann Ehler offered to make contact with an RHS representative to secure a table. Question was brought up about whether non-BPS employees are allowed to work the booth. Several current lacrosse players should be available during registration to promote and answer questions. Discussed the possibility of having an inexpensive give-away such as magnet, sticker, pen.

**Secretary:** Linda Spracklin

1. Meeting Notes: All agendas/meeting notes will be added to the website.

**IS/Web Director:** Jim Snyder

1. Web site status: Web will include meeting minutes, fundraising opportunities, sponsorship opportunities, possible Pay Pal , lacrosse events calendar, equipment vendors, map of field and school, clinics, Raider lax store vendors.
2. Booster members and coaches will provide Jim with material to be posted; it must be formatted in word and sent to him. He will filter/question all content before posting.
3. Jim explained how to access webmail through the website and provided individual passwords. He agreed to provide detailed instructions to home emails.
4. All future emails should be communicated through raiderlax.net.
5. Upcoming features on website: Booster members/coaches will be able to publish/unpublish their own documents; automatic transfer of emails from home/lax site.

**Equipment/Grant Director:** Shelly Sutherland

1. Uniforms: Shelly will work with coaches to pick out uniforms. Uniforms need to be ordered in August. It was suggested that player's number be printed on the pinnie and the name of the player on the tail of the undershirt. This will allow the team to reuse the pinnie from year to year. Our goal is for players to have matching uniforms (cleats, socks, shorts, helmets) but realize that this will be a slow process since some players have already invested in their own equipment/cleats.
2. Grants: Shelly will make contact with Tim Parker (Lax World), USlacrosse.org and Florida Lacrosse Classic for uniforms/equipment/grants.
3. Player uniforms: It was decided that the club will provide players with jerseys, shorts, socks, helmet decal and a practice pinnie. A grant could possibly cover goalie equipment.
4. Additional grants: Shelly will contact Sports Authority and Dicks. Ann will provide her with a copy of a completed grant.
